7. REGULAR BUSINESS

A. DISCUSSION AND POSSIBLE ACTION REGARDING THE APPROVAL OF RESOLUTION #2016 - 0009 - AMENDMENT AUTHORIZING GOLDER RANCH FIRE DISTRICT TO ENTER INTO A SEVEN YEAR CAPITAL LEASE AGREEMENT WITH J.P. MORGAN CHASE BANK IN THE AMOUNT OF \$893,824.58 WITH A 2.44% INTEREST RATE INSTEAD OF A 2.35% INTEREST RATE TO FINANCE A SMEAL 75' REAR MOUNT AERIAL LADDER QUINT AND ASSOCIATED FIRE EQUIPMENT

However, the final documents that were received from Chase Bank had an interest rate of 2.44% instead of the 2.35%, which was in the original resolution. This agenda item is to approve the amendment of Resolution #2016-0009 to reflect the updated interest rate of 2.44% to finance the Smeal 75' Rear Mount Aerial Ladder Quint and associated fire equipment.
