6. REPORTS AND CORRESPONDENCE

- A. FIRE CHIEF'S REPORT Chief Karrer presented his report to the Governing Board. He added that the Arizona Fire Chiefs Association (AFCA) and Arizona Fire Districts Association (AFDA) held their annual conference together. He, Chief Abel, and Chief Horvath attended. Chief Karrer and Chief Horvath met with Hunter Moore with the governor's office to discuss the consolidation process. Chief Karrer thanked Chief Horvath for setting up the meeting. He added that this has already been active Wildland season.
 - LEADERSHIP TEAM REPORT President Lunde stated that the 4th of July Celebration was a big success. The Union sold hamburgers at the event and raised \$1800 for their charity fund. Vice President Howe and President Lunde attended AFCA/AFDA conference. President Lunde has been working with President Hatfield [from MVFD] on consolidation.
 - COMMUNITY RELATIONS REPORT Manager Braswell presented her report to the Board. She added that we [GRFD] are actively participating with KVOA collecting school supplies for area schools. She continued that there is an HOA in Sun City who began collecting donations for the Wildland Team; she wanted to publically thank them.
- B. OPERATION CHIEF'S REPORT Chief Brandhuber presented his report to the Governing Board. He had nothing additional to add. There were no further questions or comments from the Board.
- C. ADMINISTRATIVE SERVICES CHIEF'S REPORT Chief Abel presented his report to the Governing Board. The Fire and Life Safety Division has completed 100% of inspections, this is over 1000 occupancies, for this fiscal year. Derek Rotekier passed his Inspector I and Brenda Staggs passed her Inspector II test; he congratulated them both.

7. REGULAR BUSINESS

A. DISCUSSION AND POSSIBLE ACTION REGARDING THE GOLDER RANCH FIRE DISTRICT RECONCILIATION AND MONTHLY FINANCIAL REPORT



Finance Manager Christian presented the monthly financials and reconciliation, as well as the end of year wrap-up for the fiscal year 2016-2017 budget to the Board. There were no further questions or comments from the Governing Board.

MOTION by Vice Chair Brady to approve and accept the Golder Ranch Fire District reconciliation and monthly financial report as presented MOTION SECONDED by Clerk Dahl MOTION CARRIED 5/0

B. PUBLIC HEARING REGARDING THE PROPOSED CONSOLIDATION OF THE GOLDER RANCH FIRE DISTRICT THE MOUNTAIN VISTA FIRE DISTRICT

Chief Karrer and Chief Horvath thanked the Board and the staff of both districts for all of the work that has been completed to get both Districts to this point. Both chiefs stated that the consolidation was still in the best interest for the communities served.

Scott Somers and Mike Burton from Fitch and Associates presented to the Governing Board the final report from the fire district consolidation feasibility study that was completed. They used a variety of outside resources to provide an independent review of the feasibility of the consolidation as well as an in-depth study of both districts financial information. They presented the financial impacts to both Districts including debts, liabilities and assets. They provided and discussed with the board an overview of the benefits to each agency and the efficiencies that would be realized due to the economy of scale, such as possibly reduced workers compensation insurance and health insurance examples. They explained that possible revenue increases related to ambulance transportation would be contingent on the possibility of CON expansion. It was made clear that this was a separate application process through the Arizona Department of Health Services and that once the Districts were consolidated; a request could be made to expand the CON if the District so chose. They further explained and discussed the potential injuries to the consolidated District and the residents as: costs to rebrand Mountain Vista assets, cost of uniforms for new personnel, debt incurred by Mountain Vista Fire District that would be absorbed by Golder Ranch Fire District, cost associated with the transfer of titles and official documents and unknown expenses that have yet to be discovered.

Board Member Clark stated thanked the Fitch and Associates representatives for their work. He continued that he believes that the consolidation of two well-run districts is a good idea. He continued that the idea of a seven-person board does not appeal to him. Chairperson Cox Golder stated that we have discussed the idea of an Emergency Services Commission to be represented by residents of the Mountain Vista Fire District.

Chief Karrer stated that the letters from both Pinal County and Pima County, as well as, the resolutions from the Town of Oro Valley and the Town of Marana were included in the board packet for the Board's review. Chairperson Cox Golder stated that she has also had members from these Boards personally express their support for the consolidation.
